Show Us Your Shorts 2018

Each year the film society runs a Youth Initiative Short film competition as part of the Warburton Film Festival called Show US Your Shorts. The planning for this program usually commences now and we are looking for a member interested in coordinating this program. This role suits a person interested in encouraging young filmmakers and developing a film culture in short film. We will provide lots of support and guidance to you, based on our previous experience. Talk to a Committee member at the OCTOBER Screening if you would like to be part of this. We need you to step forward.

End of Year Dinner

This year the end of year dinner provided prior to the December screening will have a catering charge of \$10 per person. Bookings will be required prior to the event to assist with our catering. More details for purchasing tickets for the dinner will be provided in the November newsletter.

Film selection guidelines.

At this time of the year we seriously think about of a film program for the next year. We have a democratic process which begins in July and is finalised in November before the December screening.

To start the ball rolling, the committee members are asked to suggest any films that they may have seen. With the Melbourne International Film Festival happening in July, many people get to see a range of new recent releases which are not yet screened at the cinemas. There are usually many suggestions from these. It is a great start towards putting together a film program. This is followed by a member suggestion sheet available at the September screening and a newsletter request for members to email suggestions. All members are encouraged to add their suggestions to this list. Again, many members, especially those who have a strong interest in film, are able to make great recommendations. All the suggestions are then compiled and we call this the long list of possible film screenings. All suggestions are considered and then a number of criteria are applied to produce the short list. Some of the criteria to be considered for a film to progress from the long list to the short list include:

Are the screening rights available?

Is there a copy of the film available?

Has the film been shown recently in the local commercial cinemas?

Is there a mix of international films suggested?

What classic or "from the vault" films are included? For our program, we currently choose to screen 3 films from the vault and the rest are recent releases.

The short list is circulated to members in the October newsletter and through email and all members are asked to vote, either [online through SurveyMonkey link](#) or by paper at the October screening. The results from this voting survey produce the final 11 selected films for the year, which are then put together into a screening program and sent to the publishers. Last years selection were the top films voted for by the members from the short list. Again, screening availability and local cinema programming may impact of the final 11 selection. The screening dates for each film is selected by the committee and a program is prepared for the printers and for electronic publishing. These are available to the public, including the film society community, before the December screening. This provides an opportunity to encourage new members to our film society, as well as provide an informed decision for current members to renew their membership at the December screening.

The result is another year's fabulous films able to be seen in the local community through Yarra Ranges Film Society membership.

REGARDING FILM SELECTION:

Many thanks to all those members who provided suggestions for our program in 2018. The committee has considered all titles and produced a short list of 32 for members' consideration.

Titles were eliminated from the original list using the following major criteria:

1. Films previously screened by Yarra Ranges Film Society or screened locally in Healesville and Warburton
2. Films known to be unavailable in a format suitable for screening in our cinemas
3. Films whose Australian release situation is as yet unknown

Any film to be screened in our program must firstly be available in a format compatible with the digital projection system used in our cinemas. This can be either a DCP (cinema standard digital print provided by distributors), blu-ray or standard DVD disc, in order of preference based on picture quality.

Secondly, the film must have a rights holder for Australia, to whom a screening fee is to be paid. These can sometimes be difficult to trace. In some instances with older films, even though a disc may exist, there is no rights holder as the rights have lapsed. In such circumstances, a film cannot be shown.

Members should be aware that all films on the short list are subject to these conditions, and the availability of any particular title is not guaranteed at this stage.
